I agree to adopt the above puppy from Greenmore Farm Animal Rescue (GFAR) as a pet for me and my family. I understand that GFAR is transferring ownership of the puppy to me and that if I do not adhere to any of the following conditions, GFAR reserves the right to reclaim my puppy immediately.

**If not yet altered, my puppy will be altered in accordance with the attached Spay/Neuter Agreement.*

My puppy will always have access to water and will be fed daily;
 My puppy will visit a veterinarian within 2 weeks of adoption and will have yearly wellness visits;
 My puppy will be leash-walked or exercised regularly in a fenced-in area;
 My puppy will always wear an appropriately snug-fitting collar or harness when outside my home;
 My puppy will not be tethered to a tie-out line or trolley, and I will avoid using a retractable leash;
 My puppy will not be left outside to roam freely or kept outside during cold or inclement weather.

My puppy will not be taken into high exposure areas (e.g., dog parks) and will not be around other dogs with unknown vaccination history until 10 days after their vaccination series has been completed.

If my puppy's microchip is not yet inserted, I will ask my veterinarian to insert it at an appropriate time. I will register my puppy's micro-chip within 72 hours of its insertion, according to the instructions I was given.

I agree not to abandon, give away, sell, or surrender my puppy to an animal shelter. I will notify GFAR if I wish to return my puppy and, and I will do as soon as it can be arranged and as kennel space allows. I understand that GFAR is not able to take back animals that have become aggressive to humans. Should my puppy develop an untreatable health or behavioral condition, I will consult my veterinarian as to how to proceed humanely.

I understand that puppies may come into the rescue with incomplete health or behavioral histories. GFAR takes care of the puppies' health needs at the rescue, but does not retain copies of the health summary. Once I adopt my puppy, I assume all the risks and expenses of its lifetime care and treatment.
